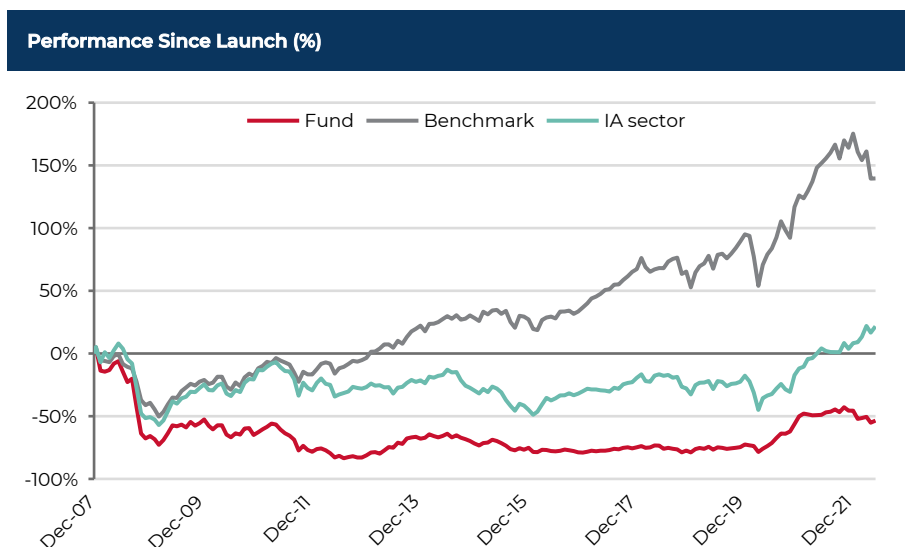

Provides pureplay exposure to global renewable energy markets. 50% top down, 50% bottom up. Value bias in bottom-up stock selection.

Concentrated equally-weighted portfolio of 30 positions. Majority of Fund invested in stocks over \$500m in size.

Investment Policy

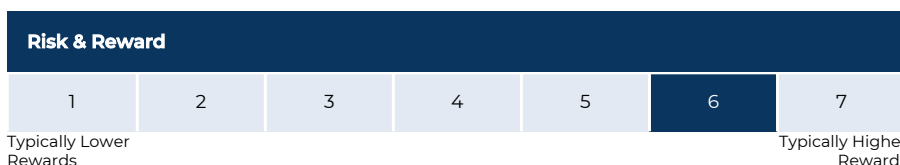
An equity fund which invests in companies in the solar, wind, hydro, geothermal, biofuels, biomass and energy efficiency sectors.

This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility.
